Terms & Conditions:

- 1) The number of posts may vary according to the project requirement.
- 2) The above posts are on temporary basis only.
- 3) Age relaxation will be as per ICMR guidelines.
- 4) Upper age limit is relaxable up to 5 years in case of candidates belonging to SC/ST and 3 years in case of OBC category as per DoPT rules. The candidates should ensure that they belong to the OBC category while applying the project posts. Such candidates should produce a valid OBC-Non Creamy Layer certificate in the prescribed format during document verification that he/she does not belong to the creamy layer. The OBC certificate shall not be older than one year at the time of joining the post. In case of not complying with these stipulations, their candidature or OBC reservation will not be entertained.
- 5) The Director & Appointing Authority has the right to accept/reject any application without assigning any reason(s) and no correspondence in this matter will be entertained.
- 6) Since, the posts are temporary; the incumbents selected will have no claim for regular appointment at ICMR-NIN or continuation of his/ her services in any other project.
