

2	Period of Consultancy	:	<b>1 year</b> on full time contract basis. The contract can be terminated by either side at any time, by giving one months' notice.
3	Nature of duties	:	Statistics support to research studies
4	Age Limit	:	45 years
5	Qualification / Essential	:	<b>Essential Qualification:</b> First (or) Second class Master's Degree from a recognized University in Biostatistics/Statistics /Data Science/MPH with atleast 5 years R & D /Working experience in Govt./Public Sector/Private Institutes as evidenced by published papers
6	Desirable Criteria	:	Ph.D in (Biostatistics/Statistics/relevant field) Experience in meta-analysis, implementation research, operational research / data analysis.
7	Remuneration & Entitlement	:	i. The consultant will be paid an all-inclusive consultant fee @ <b>Rs.50,000/- pm</b> in terms of mutual agreement agreed upon. ii. The employment will be strictly contractual, and will not confer any other benefits such as honorarium, dearness allowance, residential telephone, transport facility, residential accommodation, personal staff, CGHS and Medical Reimbursements etc., iii. Leave : Consultant shall be eligible for 10 days leave at par to 8 CL & 2 RH in year on pro-rata basis. a. No TA/DA shall be admissible for joining the assignment or on its completion. However, consultant shall be allowed TA/DA for their travel domestically in connection with the official work as per his/her entitlement at the time of retirement in case of govt. servant.
